



Warranty & Return Policy

Frame Warranty

All Greencorner wood umbrella frame parts have a limited warranty for a period of 3 years from the original date of dealer's or consumer's invoice, covering manufacturer defects alone. Each part of a Greencorner umbrella frame system is carefully designed to be easily replaced by the consumer. In the rare event a part is determined defective, after Greencorner inspects images provided by the customer, Greencorner will send the part as long as the consumer pays for the shipping of the replacement part. Please note only the manufacture defected part will be replaced, not the whole umbrella.

Canopy Warranty

Greencorner's fabric is backed by a 5 year limited warranty from the original manufacturer of the fabric. In the event the canopy material should break down, send us a sample of the defective canopy for analysis. Please note that inspection will take a long time, especially if Sunbrella fabric. The canopy will be replaced upon defect confirmation from the fabric company, as long as the consumer pays for the cost of shipping a new canopy. Only the fabric would be replaced if the canopy is defected.

WARRANTY & RETURN POLICY TERMS AND CONDITIONS

Damages produced by improper mounting, contact with other objects, inappropriate installation, assembly, operation or handling, cleaning with abrasive products, modifications, other types of accidents, misuse and neglect, acts of nature, unauthorized attachments or lack of reasonable maintenance resulting in tears, stains and other breakage are not covered.

1. The terms, conditions and pricing are subject to change without notice.
2. Greencorner reserves the right to make design modifications without prior notice.
3. Greencorner takes no responsibility if products damaged by shipping carriers.
4. It is the customer's responsibility to check the contents of the product(s) for any damage and missing parts as soon as it is received. DO NOT ACCEPT THE PRODUCT(S) WITHOUT FIRST INSPECTING IT. If delivered while no one is there be sure to take images before moving package(s) of any external damage before inspecting the contents. If the product is damaged from shipping, contact the company you purchased from immediately. You will be accepting the current state of the package and contents AS-IS if signed or accepted. Alert Greencorner within 24 hours of shipment arrival.
5. All custom orders void all warranty and cannot be canceled, returned, nor exchanged after purchase.
6. Custom orders identified as: non-stocking fabric, double wind vents, design options, and any alteration to products.
7. "Clearance" and "discontinued" products are purchased "as is" and does not have any warranty, cannot be returned, cannot be exchanged, and the order cannot be canceled. All umbrella bases are also "as is", as imperfections will occur due to several elements on the bases being done by hand.
8. It is solely up to our discretion to accept any return merchandise under any circumstance. Absolutely no refunds will be issued after 14 days from receipt. All merchandise must be exchanged no later than 30 days from receipt. Order cancellations and returns must be requested in writing. All returns require an RMA number for acceptance.
9. Purchaser is responsible for ALL shipping charges on cancellations, returns, exchanges, and warranty replacements.
10. All orders, even if cancelled, are subject to a restocking fee of 25% retail price (MSRP).
11. Quoted pricing is only valid up to 14 days unless otherwise stated. Purchasing is consent agreement to the quoted price and products, so no changes can be made after purchase.
12. Greencorner reserves the right to warranty all products to the original purchaser only.
13. Labor charges connected with installation of replacement parts are not covered by Greencorner. Consumer must replace parts themselves, with no aid from Greencorner.
14. By purchasing, you expressly consent to our general terms, conditions, and warranty of sale as printed herein.
15. To the extent permitted by law, Greencorner products shall have no liability to the purchaser or any other person for incidental, special, consequential, indirect or similar damages of any kind or nature whatsoever, whether arising out of breach of warranty or other breach of contract, negligence or other tort, or otherwise, even if Greencorner products shall have been advised of the possibility or likelihood of such potential loss or damage. In no event shall Greencorner products be liable for loss of profits and/or wages.
